Consists of 6,605 Class A common units of limited partner interest ("Class A OP Units") in NSA OP, LP (the "Partnership") held by George L. Chapman, Revocable Trust, for the benefit of George L. Chapman, which are issuable upon the conversion of 6,605 long-term incentive plan units ("LTIP Units") in the Partnership. The Reporting Person is trustee and has or shares

 - (1) voting and investment power. The LTIP Units were granted to the Reporting Person under the Issuer's 2015 Equity Incentive Plan, and are scheduled to vest on May 18, 2021. Vested LTIP Units, after achieving parity with Class A OP Units, are eligible to be converted into Class A OP Units on a one-for-one basis upon the satisfaction of conditions set forth in the Partnership's agreement of limited partnership.

Upon conversion of such vested parity LTIP Units into Class A OP Units, the Reporting Person will have the right to cause the Partnership to redeem a portion of the Reporting Person's
 - (2) Class A OP Units for cash in an amount equal to the market value of an equivalent number of the Issuer's common shares of beneficial interest ("Shares"), or at the Issuer's option, Shares on a one-for-one basis, subject to certain adjustments.
 - (3) N/A
 - (4) The price of the derivative securities was determined using the closing price of the Issuer's Shares on May 19, 2020.

The Reporting Person's total direct and indirect beneficial ownership following the reported transactions above is 39,333 Class A OP Units, which includes those Class A OP Units previously reported and the Class A OP Units reported herein (together with those securities convertible into, or exchangeable for, such Class A OP Units as specified herein and therein).
 - (5) Following the reported transactions, the Reporting Person has total direct and indirect beneficial ownership in 5,032 vested LTIP Units and 6,605 unvested LTIP Units. The 39,333 Class A OP Units do not include non-derivative securities of the Reporting Person that were previously reported.

Consists of 8,161 LTIP Units held by the George L. Chapman, Revocable Trust, for the benefit of the Reporting Person which were converted into 8,161 Class A OP Units as described in footnote 1 above. The Reporting Person previously reported the 8,161 LTIP Units that were converted into Class A OP Units as described in this Form 4 as Class A OP Units on an as-converted basis. Accordingly, rows 2 and 3 of this Form 4 are being filed on a voluntary basis solely to provide notice of the conversion of the Reporting Person's 8,161 LTIP Units into 8,161 Class A OP Units.
